14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

I. Modification Four (4) is hereby issued to delete CLIN #3 in it's entirety for the Routine Maintenance Support Services for IBM Laser Printer 4039/Opra 12 R, (44 units @ \$1,391.05 per month x 8 months), for a total decrease of \$11,128.40, effective February 2002.

II. Also, CLIN #1 is hereby increased from a quantity of 175 to 191, at a unit price of \$264.17 each per month, effective June 2002, for a total increase of \$16,906.88

Therefore, the decrease of \$11,128.40 and the increase of \$16,906.88 amount to a total increase of \$5,778.48. The ESTIMATED total dollar amount of the contract is INCREASED by \$5,778.48 from \$2,124,026.43 to \$2,129,804.91

ALL OTHER TERMS AND CONDITIONS OF THE ORIGINAL CONTRACT REMAIN UNCHANGED.
