- I. The purpose of this subject modification is to reflect hourly rate increases to the applicable labor categories as a result of U.S. Department of Labor Wage Determination 1994-2431, (Revision 19), dated June 7, 2002. All of the labor categories were affected with the exception of the Project Supervisor, which is exempt from the Service Contract Act. The revised composite rates in Part I, Section B are amended by authority of Contract Clause 3.6.2-30, Fair Labor Standards Act and Service Contract Act—Price Adjustment and Contract Clause 3.10.1-14, Changes—Time and Materials or Labor—Hours, retroactive to October 23, 2002.
- II. The following changes are hereby made to the Price Schedule listed in Part I, Section B, “Supplies or Services and Price/Costs” listed on contract page 5.
- a. **OPTION YEAR THREE** (10-23-02 to 10-22-03), previously listed on page 5 is hereby deleted in it’s entirety, and replaced with the revised **OPTION YEAR THREE**, listed on attached contract page 5 (Revised).
- III. The total “**ESTIMATED**” value of this contract modification is \$547,860. The total “**ESTIMATED**” value of the contract is increased from \$1,992,394. to \$2,540,254.
